The national licence classes contribute to road safety by better matching licence classes to the types of vehicles used on Australian roads. They make it easier to move between different States and Territories.

National Driver Licence Classes







National licence classes

LICENCE CLASS	AUTHORISED VEHICLES	UPGRADING*
RIDER (R)	 Any motorcycle or motor trike. See our website on special restrictions for learner and provisional rider licence holders. 	
CAR (C)	 Any motor vehicle no more than 4.5 tonnes Gross Vehicle Mass (GVM), which carries up to 12 adults including the driver. Any implement or tractor or a car-based motor tricycle. (To find out if a vehicle qualifies as a car- based motor tricycle, contact RMS). Any single towed trailer with a GVM not greater than 9 tonnes. See our website on special restrictions for provisional P1and P2 drivers. 	
	 Any motor vehicle more than 4.5 tonnes GVM but no more than 8 tonnes GVM. Any single towed trailer with a GVM not greater than 9 tonnes. Also includes any vehicle with a GVM of no more than 8 tonnes which carries more than 12 adults including the driver. Note: There are no restrictions on the number of axles for this class of licence Also includes vehicles in Class C. 	To upgrade to this class you must have held a Class C licence (not a learner) for at least one year.
	 Any motor vehicle with two axles and more than 8 tonnes GVM. Any towed trailer must not weigh more than 9 tonnes GVM. Also includes vehicles in Class LR. 	To upgrade to this class you must have held a Class C licence (not a learner) for at least one year.
HEAVY RIGID (HR)	 Any rigid vehicle with three or more axles and a GVM of more than 8 tonnes. Any towed trailer must not weigh more than 9 tonnes GVM. Also includes articulated buses and vehicles in Class MR. 	To upgrade to this class you must have held a Class C, LR or MR licence (not a learner) for periods totalling at least two years.
	 Any prime mover attached to a semi-trailer or a rigid vehicle towing a trailer with a GVM of more than 9 tonnes plus any unladen converter dolly. Also includes vehicles in Class HR. 	To upgrade to this class you must have held a Class MR or HR licence for at least one year. P2 licence holders cannot upgrade to this class.
MULTI COMBINATION (MC)	 Any B-Double or road train. Also includes vehicles in Class HC. 	To upgrade to this class you must have held a Class HR or HC licence for at least one year. P2 licence holders cannot upgrade to this class.
